The Los Angeles County Public Works (Public Works) is responsible for the construction, operation and maintenance of facilities in the unincorporated County jurisdiction. Such facilities include Airports, Code Enforcement, Flood Control System, Graffiti Removal, Road Maintenance, Solid Waste Management, Street Sweeping, Tree Trimming, Traffic Systems, and Waterworks & Sewer Systems. The details below are the contacts, operations, and services we provide.

CODE ENFORCEMENT/PROPERTY REHABILITATION

Code Enforcement is directed at private property violations of the Los Angeles County Building Codes and is initiated with an administrative action.

Cases fall into three primary areas:

- **Unsafe & Un-permitted Buildings**
- **Non-inspected Work**
- **Property Rehabilitation Program**

Public Works is responsible for the ongoing operations and maintenance of the Flood Control Facilities.

GRAFFITI ABATEMENT

Public Works is responsible for graffiti removal on County rights of way in the unincorporated areas and flood control facilities. RAILROAD ISSUES

ROAD IMPROVEMENTS

WATERWORKS

Public Works operates and maintains five separate Waterworks Districts located in the Cities of Lancaster, Palmdale, and Malibu and in the unincorporated County areas of Acton, Val Verde, Pearblossom, Littlerock, Rock Creek, Sun Village, Lake Los Angeles, and northeast Los Angeles County. Public Works also maintains the Marina del Rey water system for the Department of Beaches and Harbors.
